Asia Precision Public Company Limited ("the Company") would like to make clarification on the performance results for the year ended 31 December 2020 of the Company and its subsidiaries, as follow:

Operating Results:

Overall operating results of the Company and its subsidiaries in the consolidated financial statement for the year ended 31 December 2020 compared with same period of 2019 are as follows: Revenue decreased by Baht 655 million (23.5%). Profit for the period decreased by Baht 261 million (82.9%). and Profit attributable to owners of parent decreased by Baht 224 million (94.1%).

- Revenue from AUTO business decreased due to the outbreak of COVID-19, which caused the economic slowdown
 and directly impacted the global supply chain
- 2. Revenue from EPC business decreased due to the outbreak of COVID-19, which delay some clients' decisions to move forward with the projects in pipeline; although, the proportion of clients in this category is not high. Nevertheless, the Company had adjusted target revenue recognition to reflect the current situation.
- Revenue from WATER business decreased due to the outbreak of COVID-19 and draught situation. Nevertheless,
 the company prepared sufficient water to deliver to meet the contract. The increase in cost was due to higher wages
 and depreciation.

Operating Results:

Overall operating results of the Company and its subsidiaries in the consolidated financial statement for the year ended 31 December 2020 are as follows: Revenue Q1'20 Baht 422 million, Q2'20 Baht 278 million, Q3'20 Baht 669 million, Q4'20 Baht 764 million. Profit for the period: Q1'20 loss for operating Baht 63 million, Q2'20 loss for operating Baht 18 million, Q3'20 Profit Baht 48 million, Q4'20 Profit Baht 47 million.

Due to the impact from the outbreak of COVID-19, operating performance in Q1'20 and Q2'20 resulted in a loss as a result of lower revenue. Nevertheless, revenue and operating profit recovered back to the normal level in Q3'20 and Q4'20.
